Guaranteed—All men shall have a remedy by the due course of law. If a remedy does not exist, or if the existing remedy has been subverted, then one may create a remedy for themselves and endow it with credibility by expressing it in their affidavit. (Ignorance of the law might be an excuse, but it is not a valid reason for the commission of a crime when the law is easily and readily available to anyone making a reasonable effort to study the law.)

All corporate government is based upon Commercial Affidavits, Commercial Contracts, Commercial Liens and Commercial Distresses; hence, governments cannot exercise the power to expunge commercial processes.

The Legitimate Political Power of a corporate entity is absolutely dependent upon its possession of Commercial Bonds against Public Hazard, because no Bond means no responsibility, means no power of Official signature, means no real corporate political power, means no privilege to operate statutes as the corporate vehicle.

The Corporate Legal Power is secondary to Commercial Guarantors. Case law is not a responsible substitute for a Bond.

Municipal corporations which include cities, counties, states and national governments have no commercial reality without bonding of the entity, its vehicle (statutes), and its effects (the execution of its rulings).

Except for a Jury, it is also a fatal offense for any person, even a Judge, to impair or to expunge, without a Counter-Affidavit, any Affidavit or any commercial process based upon an Affidavit.

Judicial non-jury commercial judgments and orders originate from a limited liability entity called a municipal corporation, hence must be reinforced by a Commercial Affidavit and a Commercial Liability Bond.

A foreclosure by a summary judgment (non-jury) without a commercial bond is a violation of commercial law.

Governments cannot make unbonded rulings or statutes which control commerce, free enterprise citizens, or sole proprietorships without suspending commerce by a general declaration of martial law.

It is tax fraud to use Courts to settle a dispute/controversy which could be settled peacefully outside of or without the Court.

An official (officer of the court, policeman, mayor, city council member, etc.) must demonstrate that he/she is individually bonded in order to use a summary process.

An official who impairs, debauches, voids or abridges an obligation of contract or the effect of a commercial lien without proper cause, becomes a lien debtor and his property becomes forfeited as the pledge to secure the lien. Pound breach (breach of impoundment) and rescue is a felony.

It is against the law for a Judge to summarily remove, dismiss, dissolve or diminish a Commercial Lien. Only the Lien Claimant or a Jury can dissolve a commercial lien.

POINTS OF LAW/CASE CITES

PUBLIC HAZARD BONDING OF CORPORATE AGENTS

All officials are required by federal, state, and municipal law to provide the name, address and telephone number of their public hazard and malpractice bonding company and the policy number of the bond and, if required, a copy of the policy describing the bonding coverage of their specific job performance. Failure to provide this information constitutes corporate and limited liability insurance fraud (15 USC) and is prim-a-facie evidence and grounds to impose a lien upon the official personally to secure their public oath and service of office.

Donna Joy Varney, Alissa Tyler, Charles Tyler, Gayle Baingo, and Theresa Vos (as a Real Parties in Interest) notice, regardless if deemed in-artfully plead, must be held to a less stringent standard than formal pleadings drafted by bar-admitted attorneys and **can only be dismissed for failure to state a claim if it appears beyond a doubt that Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos can prove no set of facts in support of [their] claims which would entitle them to relief.**" [in the nature of Haines v. ALLEGATIONS

Allegations arise from the conduct of City of Sedona's Mayor, Sandy Moriarty, City Attorney, Kurt Christianson, and City Council Members, Scott Jablow, Kathy Kinsella, Tom Lamkin, Holli Ploog, Jon Thompson, and Jessica Williamson. bonded and d/b/a SANDY MORIARTY, MAYOR; KURT CHRISTIANSON, CITY ATTORNEY; SCOTT JABLOW, VICE-MAYOR; KATHY KINSELLA, COUNCIL MEMBER; TOM LAMKIN, COUNCIL MEMBER; HOLLI PLOOG, COUNCIL MEMBER; JON THOMPSON, COUNCIL MEMBER; JESSICA WILLIAMSON, COUNCIL MEMBER from January 1, 2021 through May 24, 2022. The allegations below follow those recorded in the minutes and actions of the Sedona City Council, Mayor and City Attorney.

1. The above listed lien debtors/joint tort feisors are committing an ongoing tort against the private and public interests of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by denying the true facts associated with Alternative Expenditure Limitation (Home Rule) and implementing projects with only a pretense of voter input to effectively disguise the true nature of various city projects (retort) thereby under color of law engaging in constitutional infringement, denying We the People of Sedona the right of constitutional due process.
2. The above listed lien debtors/joint tort feisors have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by condoning city staff and committee members to use false narratives and fear tactics to manipulate the voting populace to maintaining Alternative Expenditure Limitation (Home Rule) when in reality there is no fair and honest comparison of the statistics so the public can have a balanced view of the true nature of the State Baseline Expenditure Limitation versus the Alternative Expenditure Limitation, effectively denying the citizens of Sedona their constitutional right to notice and due process.

The above listed lien debtors/joint tort feasons have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos through public funding of a private entity (Chamber of Commerce) that in turn promotes a false narrative to the businesses and people of Sedona through their marketing strategies to maintain the Alternative Expenditure Limitation (Home Rule), thereby continuing to enable the gross misuse of Public/Private contract and gifting from the City of Sedona to the Chamber of Commerce, effectively denying the citizens of Sedona their constitutional right to due process.
4. The above listed lien debtors/joint tort feasons have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by entering into a No Bid contract with the Chamber of Commerce circumventing the constitutional right to notice and due process for the citizens of Sedona.
5. The above listed lien debtors/joint tort feasons have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos misrepresent the statutes and portray the law to read as if they must gift 55 percent of the bed tax to the Chamber of Commerce. The City Council provides liaisons to continually direct the Chamber of Commerce to assist in pushing through Chambers agendas without regard to the true benefit of the businesses within the city limits which contribute to the bed tax and sales tax, effectively embedding the Chamber of Commerce into the City as a Quasi-Government and formally memorializing the Chamber of Commerce as they enter into a partnership without a tourism bureau, thus violating the constitutional rights for We the People of Sedona, as well as ignoring the tourism statutes.
6. The above listed lien debtors/joint tort feasons have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by fraudulently creating a tourism district/authority, which must be voter approved, as it stands outside the realm of the jurisdiction of the City Council, thus violating the constitutional right to notice and due process of We the People of Sedona
7. The above listed lien debtors/joint tort feasons have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by fraudulently imposing taxation on the businesses and citizens of Sedona relative to a fraudulent tourism authority that is not within the scope of jurisdiction for the City Council or the Chamber of Commerce to pursue, thus blatantly denying the constitutional right to notice and due process of We the People of Sedona.
8. The above listed lien debtors/joint tort feasons have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by entering into public/private contract with the Chamber of Commerce providing them 55 percent of all city bed tax in violation of the Attorney General's report to claw back the Chamber's contract removing the automatic payment remittance to eliminate the impropriety of "gifting" to a private company, effectively violating the businesses and citizens of Sedona their constitutional right to due process.

The above listed lien debtors/joint tort feasons have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by removing all transparency with how bed tax monies are utilized through their “gifting” to the Chamber of Commerce. This constitutes a serious abuse of discretion by the City Council where the Chamber of Commerce determines who benefits and who does not, creating a situation where in-city businesses pay for the marketing of out-of-city business through city taxes, blatantly denying the in-city businesses the constitutional right to due process.
10. The above listed lien debtors/joint tort feasons have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by entering into a public/private partnership with the Chamber of Commerce without any measure of accountability for the use of taxpayer monies effectively comingling private and public funds in violation of taxpayers’ constitutional right to due process.
11. The above listed lien debtors/joint tort feasons have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by manipulating city monies through various funds to show a false narrative of profit and loss for wastewater management and denying the people of Sedona a transparent representation of accounting; thus, denying the constitutional right to due process for the citizens of Sedona.
12. The above listed lien debtors/joint tort feasons have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by use of city websites and other marketing materials to falsely represent the Sedona Public Library as a city library rather than a county library in order to manipulate the voters to believe the library’s success and financial stability is solely reliant on the city in an attempt to mislead voters to maintain the Alternative Expenditure Limitation (Home Rule), effectively denying the citizens of Sedona their constitutional right to due process.
13. The above listed lien debtors/joint tort feasons have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by tainting the bidding process regarding the transit system contract. The time allotted was not sufficient for contractors, local or otherwise, to do their due diligence without insider knowledge; thus, violating the constitutional right to due process for local bidders and the citizens of Sedona.
14. The above listed lien debtors/joint tort feasons have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by creating transit hub parking in close proximity to the public grade school. It creates a dangerous environment for children coming and going from school and for the use of the nearby community park. It also drives the bulk of the tourism traffic to the middle of West Sedona increasing traffic congestion and danger in a primarily residential section of Sedona.

The above listed lien debtors/joint tort feasons have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by manipulating the standard planning and zoning plan to obtain a desired result without input or approval of the residents; thus, violating the city's own policies and procedures and the constitutional right to due process for the citizens of Sedona.
16. The above listed lien debtors/joint tort feasons have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by violating the City's own policies and procedures for Planning and Zoning and manipulating the planning and zoning proposal that came to a vote of the council to be more lenient with structural limitations in a Community Focus Area; thus violating the constitutional rights to due process for the citizens of Sedona.
17. The above listed lien debtors/joint tort feasons have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by denying property owners' proper notice of the condemnation of property and right to contract, regarding the fair exchange of property, the City Council is effectively confiscating, condemning, and destroying property in violation of the property owners' constitutional right to due process.
18. The above listed lien debtors/joint tort feasons have unlawfully distressed the Property Rights of We the People of Sedona, Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by violating the 2017 Arizona Revised Statutes Title 38, which prohibits holding office or interest in committees, organizations or businesses that would benefit in any way by the decision or vote of the City Council severally or jointly the City Council is in violation of the constitutional due process of the citizens of Sedona.

PROOF OF ALLEGATIONS

The proof of the allegations are contained in the Sedona City Council's minutes, videos, actions, deeds, contracts, financials and factual documentation throughout their term of office.

Ledgering: Ledgering for the violations of the United States Constitution and the Bill of Rights against Donna Joy Varney, Alissa Tyler® 2022, Charles Tyler® 2022, Gayle Baingo® 2022, and Theresa Vos by City of Sedona's Mayor, Sandy Moriarty, City Attorney, Kurt Christianson, and City Council Members, Scott Jablow, Kathy Kinsella, Tom Lamkin, Holli Ploog, Jon Thompson, and Jessica Williamson. bonded and d/b/a SANDY MORIARTY, MAYOR; KURT CHRISTIANSON, CITY ATTORNEY; SCOTT JABLOW, VICE-MAYOR; KATHY KINSELLA, COUNCIL MEMBER; TOM LAMKIN, COUNCIL MEMBER; HOLLI PLOOG, COUNCIL MEMBER; JON THOMPSON, COUNCIL MEMBER; JESSICA WILLIAMSON, COUNCIL MEMBER described in the "Allegations" above is under 18 USC 241, **CONSPIRACY AGAINST THE RIGHTS OF CITIZENS**. "If two or more persons conspire to injure, threaten, or intimidate any citizen in the free exercise or enjoyment of any right or privilege secured to him by the Constitution or laws of the United States, or because of his having so exercised the same; or if two or more persons go in disguise on the highway or the premises of another, with intent to prevent or hinder his free exercise or enjoyment of any right or privilege so secured – they shall be fined not more than \$10,000 or imprisoned not more

Maxims:

All men and women know that the foundation of law and commerce exists in the telling of the truth, the whole truth, and nothing but the truth.

Truth as a valid statement of reality is sovereign in commerce.

An un rebutted affidavit stands as truth in commerce.

An un rebutted affidavit is acted upon as the judgement in commerce.

Guaranteed—All men shall have a remedy by the due course of law. If a remedy does not exist, or if the existing remedy has been subverted, then one may create a remedy for themselves and endow it with credibility by expressing it in their affidavit. (Ignorance of the law might be an excuse, but it is not a valid reason for the commission of a crime when the law is easily and readily available to anyone making a reasonable effort to study the law.)

All corporate government is based upon Commercial Affidavits, Commercial Contracts, Commercial Liens and Commercial Distresses; hence, governments cannot exercise the power to expunge commercial processes.

The Legitimate Political Power of a corporate entity is absolutely dependent upon its possession of Commercial Bonds against Public Hazard, because no Bond means no responsibility, means no power of Official signature, means no real corporate political power, means no privilege to operate statutes as the corporate vehicle.

The Corporate Legal Power is secondary to Commercial Guarantors. Case law is not a responsible substitute for a Bond.

Municipal corporations which include cities, counties, states and national governments have no commercial reality without bonding of the entity, its vehicle (statutes), and its effects (the execution of its rulings).

Except for a Jury, it is also a fatal offense for any person, even a Judge, to impair or to expunge, without a Counter-Affidavit, any Affidavit or any commercial process based upon an Affidavit.

Judicial non-jury commercial judgments and orders originate from a limited liability entity called a municipal corporation, hence must be reinforced by a Commercial Affidavit and a Commercial Liability Bond.

A foreclosure by a summary judgment (non-jury) without a commercial bond is a violation of commercial law.

Governments cannot make unbonded rulings or statutes which control commerce, free enterprise citizens, or sole proprietorships without suspending commerce by a general declaration of martial law.

It is tax fraud to use Courts to settle a dispute/controversy which could be settled peacefully outside of or without the Court.

An official (officer of the court, policeman, etc.) must demonstrate that he/she is individually bonded in order to use a summary process.

An official who impairs, debauches, voids or abridges an obligation of contract or the effect of a commercial lien without proper cause, becomes a lien debtor and his property becomes forfeited as the pledge to secure the lien. Pound breach (breach of impoundment) and rescue is a felony.

It is against the law for a Judge to summarily remove, dismiss, dissolve or diminish a Commercial Lien. Only the Lien Claimant or a Jury can dissolve a commercial lien.

Notice to agent is notice to principal; notice to principal is notice to agent.

POINTS OF LAW/CASE CITES

PUBLIC HAZARD BONDING OF CORPORATE AGENTS All officials are required by federal, state, and municipal law to provide the name, address and telephone number of their public hazard and malpractice bonding company and the policy number of the bond and, if required, a copy of the policy describing the bonding coverage of their specific job performance. Failure to provide this information constitutes corporate and limited liability insurance fraud (15 USC) and is prim-a-facie evidence and grounds to impose a lien upon the official personally to secure their public oath and service of office.

Shelley Evans® 2020 (as a Real Party in Interest) notice, regardless if deemed in-artfully plead, must be held to a less stringent standard than formal pleadings drafted by bar-admitted attorneys and **can only be dismissed for failure to state a claim if it appears beyond a doubt that Shelley Evans® 2020 can prove no set of facts in support of [her] claims which would entitle her to relief.**" [in the nature of Haines v. Kerner, 404 U.S., 519-521; Richardson v. Flemming, 651 F 2d at 368 (quoting Estelle v. Gamble, 429 U.S. 97, 97 S. Ct. 285, 50 L.Ed.2d. 251, (1976); Conley v. Gibson, 355 U.S. 41, 78 S. ALLEGATIONS

Allegations arise from the conduct of Paul Schlegel acting as JUDGE for and Brian Armstrong acting as SENIOR CODE ENFORCEMENT OFFICER in SEDONA MUNICIPAL COURT, YAVAPAI/COCONINO COUNTY, ARIZONA from February 17, 2022 through July 11, 2022. The allegations below follow those recorded in the included "LEDGER AND TRUE BILL" contained herein.

1. The above listed lien debtors/joint tort feasons are committing an ongoing tort against the private and public interests of Shelley Evans® 2020 by disregarding jurisdictional boundaries and failing to "prove" subject matter jurisdiction as required by the Arizona Revised Statutes and Sedona City Codes.
2. The Judge, lien debtor/joint tort feason, denied the challenge to jurisdiction without proving jurisdiction; thus, directly violating the due process rights of Shelley Evans® 2020 to have jurisdiction proven before proceeding.
3. The Judge, lien debtor/joint tort feason, acquiesced to the fact that I own the entity of SHELLEY EVANS® 2020, the fictional entity created by the State of Oklahoma disregarding the depth of that implication while failing to prove in personam jurisdiction.
4. The above listed lien debtors/joint tort feasons are committing an ongoing tort against the private and public interests of Shelley Evans® 2020 by ignoring that she is a live human being and not the entity SHELLEY EVANS® 2020 after being informed of the infringement of a registered trademark.
5. The above listed lien debtors/joint tort feasons are committing an ongoing tort against the private and public interests of Shelley Evans® 2020 by continuing to infringe upon the registered trademark of SHELLEY EVANS® 2020.
6. The above listed lien debtors/joint tort feasons are committing an ongoing tort against the private and public interests of Shelley Evans® 2020 by forcing in open court to either agree to enter an illegal contract or pay fines for failure thereof, thereby under color of law, forcing jurisdiction where there is none.
7. The above listed lien debtors/joint tort feasons have unlawfully distressed the Real Property of Shelley Evans® 2020 in an attempt to force her to contract with a corporate entity (City of Sedona) or face fines and penalties.
8. The above listed lien debtors/joint tort feasons denied/disregarded the validity of the NOTICE OF OCCUPANCY delivered by Shelley Evans® 2020 to the City of Sedona, which admittedly met the requirements of a Tenant Occupancy Packet, which she provided in lieu of an illegal contract that misrepresents the actual nature of signing such a contract.
9. The above listed lien debtors/joint tort feasons denied/disregarded the fact that aforementioned Tenant Occupancy Agreement is an illegal contract in that it represents the Ultimate Light Mission® 2020 in such a light as to invalidate the mission statement and intent of the Mission and has, thus, put her in a continual state of distress with no clear course of action to remain

within the STATUES/COLOR OF LAW.

10. The above listed lien debtors/joint tort feasons disregarded the precedence set by the City of Sedona as it allowed 7 Centers Yoga Studio, the prior occupant of the same property/site, to operate for nearly two decades without a Tenant Occupancy Agreement, which was revealed through lien debtor/joint tort feason Brian Armstrong's own testimony. 7 Centers Yoga being a highly visible entity at the forefront of the Annual Sedona Yoga Festival which was marketed world-wide by the Chamber of Commerce, and the entity also conducted Yoga Teacher Trainings that drew students world-wide and hosted seminars, events, workshops and concerts in much the same format as Ultimate Light Mission. Custom and usage is on the side of the Ultimate Light Mission.
11. I challenge the validity of both the citation and the court order as my signature is not "Refused or Refuses to Sign," as written on the signature line by both the Code Enforcement Officer and the Judge. As my refusal to sign is a refusal to concede to the Court's jurisdiction and authority and the signature line should be left blank.
12. The above listed lien debtors/joint tort feasons denied/disregarded the fact that aforementioned TENANT OCCUPANCY AGREEMENT is an illegal contract in that it represents the Ultimate Light Mission® 2020 in such a light as to invalidate the mission statement and the intent of the Mission and has, thus, put the Ultimate Light Mission in a continual state of distress with no clear course of action to remain within the STATUTES/COLOR OF LAW.

PROOF OF ALLEGATIONS

The proof of the allegations is contained in the clerk's file in Case No. LC 202200019 and in the official court record and transcripts on file at the Sedona Municipal Court Yavapai/Coconino, Arizona Office, dated July 11th, 2022.

LEDGER AND TRUE BILL

Ledgering: Ledgering for the violations of the United States Constitution and the Bill of Rights against Shelley Evans® 2020 by PAUL SCHLEGEL acting as Judge for and BRIAN ARMSTRONG acting as SENIOR CODE ENFORCEMENT OFFICER described in the "Allegations" above is under 18 USC 241, **CONSPIRACY AGAINST THE RIGHTS OF CITIZENS**. 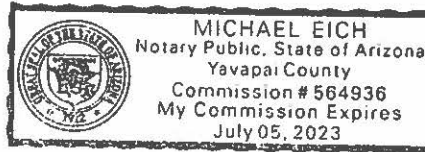
